His first job in the disability service field came when he was 20 where he provided recreation therapy at a special population recreation center. His career took him on a path that led to positions as a Para-professional, Teacher, Director of Structured Day Program for adults with

Traumatic Brain Injuries, Special Education Advocate and Coordinator of a New York State Department of Education funded Parent Center. In the fall of 2010, Joe and his family moved to the Bay Area where Joe started as Education Manager at SFCD, where he managed Education trainings, workshops, and events. He is now the Family Resource Center Education Program Director, overseeing the Education program at SFCD.

# Ron Hager, Senior Attorney at the National Disability Rights Network
