## Turn the Page. Parents' Rights and Protections.

As a parent of a child in special education, it's important to know your rights and protections. You are your child's cheerleader in this complex but essential process.

It's important to use your power wisely, calmly, and collaboratively. With your rights come responsibilities.

- **Get to know your various timelines**, as there typically are many.
- **Learn about the Prior Written Notice Policy.** This states that any request for services for your child must be accepted or rejected in writing, clearly stating the reasons for the decision.
- **Collect data to document your concerns** before bringing them to the team. When disagreements do arise (which they will), you will be less likely to cede your decision-making authority if you are well prepared.

**Your child has many people working in their interest but no one is better interested or qualified than you.**

## Turn the Page. Parents' Rights and Protections in the Early Years

As an Early Years parent, you may well be overwhelmed dealing with medical professionals, therapists, insurance companies, and your (and other family members') emotions around having a little one with a disability.

You have several rights and protections as a parent of small child with a disability. Ask for help and learn:

- **Who provides the services you need**
- **How these services are provided**
- **When they're provided**
- **How you can access them**

Professional assistance is available to help you understand eligibility decisions, dispute frequency and duration for eligible services, and deal with other challenges.

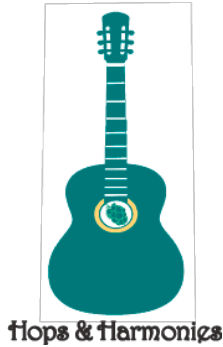

### Pasar la pagina. Derechos y Protecciones de los padres.

Como padre de un niño en la educación especial, es importante que conozca sus derechos y protecciones. Usted es animadora de su hijo en este proceso complejo pero esencial.

Es importante usar su poder con sabiduría, con calma, y en colaboración. Con los derechos vienen las responsabilidades.

- **Conozca a sus diversas líneas de tiempo**, ya que por lo general son muchas.
- **Aprender sobre el Prior Política notificación por escrito**. Este establece que cualquier solicitud de servicios para su niño debe ser aceptado o rechazado por escrito, indicando claramente los motivos de la decisión.
- **Recopilar datos para documentar sus preocupaciones** antes de llevarlos al equipo. Cuando surgen desacuerdos (que ellos), que serán menos propensos a ceder su autoridad en la toma de decisiones si usted está bien preparado.

**Su hijo tiene muchas personas que trabajan en su interés, pero nadie es mejor interesada o cualificado como usted.**

Asistencia profesional está disponible para ayudarle a entender las decisiones de elegibilidad, la frecuencia de conflictos y la duración de los servicios elegibles, y hacer frente a otros retos.
